WHAT DOES THE FUND INVEST IN?

The Fund seeks to earn a high rate of income by investing primarily in long-term fixed income securities of Canadian government and corporate issuers.

Investments by the Fund in non-Canadian securities will generally not exceed 49% of the Fund's assets taken at book value.

HOW RISKY IS IT?

The value of the Fund can go down as well as up. You could lose money.

One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

RISK RATING

Beutel, Goodman & Company Ltd. has rated the volatility of this Fund as **low to medium**.

This rating is based on how much the Fund's returns have changed from year to year. It doesn't tell you how volatile the Fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

Like most mutual funds, this Fund doesn't have any guarantees. You may not get back the amount of money you invest.

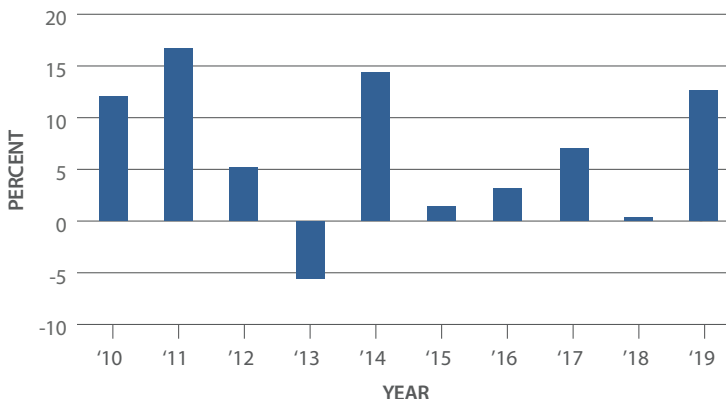
HOW HAS THE FUND PERFORMED?

This section tells you how Class I units of the Fund have performed over the past 10 years. Returns are after expenses have been deducted. These expenses reduce the Fund's returns.

YEAR-BY-YEAR RETURNS

This chart shows how Class I units of the Fund have performed in each of the past 10 years. The Fund dropped in value in 1 of the past 10 years.

The range of returns and change from year to year can help you assess how risky the Fund has been in the past. It does not tell you how the Fund will perform in the future.



BEST AND WORST 3-MONTH RETURNS

This table shows the best and worst returns for Class I units of the Fund in a 3-month period over the past 10 years. The best and worst 3-month returns could be higher or lower in the future. Consider how much of a loss you could afford to take in a short period of time.

AVERAGE RETURN

The annual compound return for Class I units of the Fund was 6.21% over the past 10 years. If you had invested \$1,000 in this class of the Fund 10 years ago, your investment would now be worth \$1,828.

WHO IS THIS FUND FOR?

Investors who:

- Have a medium to long-term time horizon
- Have a low to moderate tolerance for volatility and risk
- Seek a steady stream of income
- Have invested a minimum of \$500,000 in a Fund and who have entered into an investment management agreement with us

A WORD ABOUT TAX

In general, you'll have to pay income tax on any money you make on a fund. How much you pay depends on tax laws where you live and whether or not you hold the Fund in a registered plan, such as a Registered Retirement Savings Plan, or a Tax-Free Savings Account.

Keep in mind that if you hold the Fund in a non-registered account, fund distributions are included in your taxable income, whether or not they are received in cash or reinvested in additional units of the Fund.

HOW MUCH DOES IT COST?

The following table shows the fees and expenses you could pay to buy, own and sell Class I units of the Fund. The fees and expenses – including any commissions – can vary among classes of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

1. Sales Charges

Class I is a no load option. Sales charges are not applicable.

2. Fund Expenses

You don't pay these expenses directly. They affect you because they reduce the Fund's returns.

As of December 31, 2019, the Fund's expenses were 0.04% of its value. This equals \$0.40 for every \$1,000 invested.

Management expense ratio (MER) This is the total of the Fund's management fee (including the trailing commission) and operating expenses. Beutel Goodman waived some of the Fund's expenses. If it had not done so, the MER would have been higher.	0.04%

3. More About the Trailing Commission

The trailing commission is an ongoing commission. It is paid for as long as you own the Fund. It is for the services and advice that your representative and their firm provide to you.

Beutel, Goodman & Company Ltd. does not pay a trailing commission for this class.

4. Other Fees

You may have to pay other fees when you buy, hold, sell or switch units of the Fund.

Fee	What you pay
Management Fee	These fees are negotiated and paid directly by the investor and do not exceed 0.70%
Switch Fee	You may have to pay to your representative up to 2% of the value of the units you switch
Short-Term Trading Fee	You may have to pay the Fund up to 2% of the amount you switch or redeem if you invested in the Fund for less than 30 days

WHAT IF I CHANGE MY MIND?

Under securities law in some provinces and territories, you have the right to:

- withdraw from an agreement to buy mutual funds within two business days after you receive a simplified prospectus or Fund Facts document; or
- cancel your purchase within 48 hours after receiving confirmation of the purchase.

In some provinces and territories, you also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, annual information form, Fund Facts document or financial statements contain a misrepresentation. You must act within the time limit set by the securities law in your province or territory.
