Management Discussion of Fund Performance

Investment Objectives and Strategies

This Fund seeks long-term capital growth through investment in common stocks and other equity securities of global issuers.

The Fund invests in a limited number of mid-to-large capitalization stocks anywhere in the world, based primarily on the highest risk-adjusted return to the research target price. Each of the 20–35 holdings will be among the best businesses in their respective industries, and generators of sustainable shareholder value and free cash flow. Portfolio risk and return will be judged on an absolute basis. At all times the Fund will seek to be diversified and generally fully invested.

Risk

There were no significant changes to the investment objectives or strategies that affected the Fund's overall level of risk during the period. The risks of investing in this Fund and the suitability of the Fund for investors remain as discussed in the Prospectus.

There were no changes to the Fund's risk rating during the reporting period.

Results of Operations

Over the six-month period ended June 30, 2021, Beutel Goodman World Focus Equity Fund (the "Fund"), Class B outperformed its benchmark. Unlike the benchmark, the Fund's return is net of fees and expenses paid by the Fund. Detailed performance is provided under the heading "Past Performance" in this report.

Global equity markets remained strong over the period. Improved corporate earnings, accelerated vaccine distribution and prolonged central bank stimulus continued to strengthen markets until a spike in U.S. bond yields in February. Worries that an acceleration in economic growth would lead to rising inflation and tightening monetary policy created some uncertainty in markets. Though there may be concerns that inflation is running hotter than expected, equity markets continued to post strong returns. Against this backdrop, the MSCI World Index (CS) recorded a total return of 9.88% over the period, with Energy, Financials, Real Estate and Communication Services providing the strongest returns. Utilities and Consumer Staples, meanwhile, recorded the weakest performance in the Index.

Key Contributors to Performance

- The top-performing sectors during the period relative to the benchmark were Consumer Discretionary, Industrials and Information Technology.
 - Stock selection in the Consumer Discretionary, Industrials and Information Technology sectors contributed to the Fund's relative performance.
- Over the period, the largest individual contributors to Fund performance included IMI plc, eBay Inc., American Express Co., NortonLifeLock Inc. and Omnicom Group Inc.

Key Detractors from Performance

- From a sector perspective, the Fund's holdings in the Energy, Communication Services and Consumer Staples sectors were the largest detractors from the Fund's relative performance over the period.
 - A combination of both stock selection and an underweight position in the Energy sector, an area of relative strength in the benchmark, detracted from the Fund's relative performance.
 - Stock selection in the Communication Services sector detracted from the Fund's relative performance.
 - A combination of both stock selection and an overweight position in the Consumer Staples sector, an area of relative weakness in the benchmark, detracted from the Fund's relative performance.
- Over the period, the largest individual detractors from Fund performance included Campbell Soup Co., Verizon Communications Inc., Ampol Ltd., Smith & Nephew plc and Kimberly-Clark Corp.

Portfolio Activity

- The portfolio management team (the "team") employs a stock selection process that is based on identifying securities trading at a significant discount to their business value. The Fund's sector and stock weights are outcomes of the team's investment decisions based on bottom-up fundamentals and business quality. As a by-product of the team's bottom-up investment process, market performance and general management activity, the following changes occurred in the Fund's portfolio during the reporting period:
 - The Fund's equity weightings in the U.S. and Germany decreased due to relative performance and the team's buy/sell activities. These proceeds were largely reallocated to Fund holdings in Denmark, France and Japan.
 - The Fund's Consumer Discretionary and Consumer Staples sector weightings increased over the period because of relative performance and the team's buy/sell activities.
 - The Fund's Health Care, Information Technology and Communication Services sector weightings decreased over the period because of relative performance and the team's buy/sell activities.
 - GlaxoSmithKline plc was a new addition to the Fund over the period. Some of the more significant additions to existing Fund holdings over the period included eBay Inc., Kimberly-Clark Corp., Carlsberg A/S, Omnicom Group Inc. and Amgen Inc.
 - Smith & Nephew plc was liquidated over the period. Some of the more significant reductions in existing holdings from the Fund included Merck KGaA, Comcast Corp., Oracle Corp., AmerisourceBergen Corp. and PPG Industries Inc.
- At period-end, there were 30 holdings in the Fund, unchanged from the beginning of the period.
- The Fund's level of cash and cash equivalents ended the period up from the beginning of the period.

Recent Developments

Optimism around a potential large infrastructure plan by President Biden in the U.S. and positive trends in vaccination rates leading to a quicker-than-expected reopening of global economies have likely contributed to strong equity market performance. The market has, to a large extent, disregarded inflation concerns spurred by higher energy prices.

While these market factors are interesting, for us they serve as a reminder of why we focus on our equity investment process and the companies in our portfolios instead of attempting to forecast economic themes or time the markets. Given our unique disciplined value investment philosophy, our portfolios are unlikely to fit neatly into a predetermined definition of value. Many of our largest holdings are only now trading at levels that approach where they were pre-pandemic in terms of market price. While the market has gotten more expensive, many of our holdings remain undervalued relative to our target prices. Our focus on our process allows us to remain disciplined in searching out opportunities to own great companies trading at a discount to our estimate of intrinsic value.

Market Risk 2021

The impact of the coronavirus (“COVID-19”) pandemic on the financial performance of the Fund’s investments will depend on future developments, including the duration and spread of the outbreak and related advisories and restrictions. This public health crisis and the impact of COVID-19 on the financial markets and the overall economy are highly uncertain and cannot be predicted. If the financial markets and/or the overall economy continue to be impacted for an extended period, the Fund’s future investment results may be materially adversely affected.

Related Party Transactions

Beutel, Goodman & Company Ltd. (“BG”) is the Manager, Trustee and Portfolio Advisor to this Fund. The Fund pays a management fee to BG as compensation for its services. The Fund pays a fixed administration fee to BG, which in turn pays certain operating expenses of the Fund. BG as trustee of the Fund earns a fee which is paid by the Manager from the fixed administration fee paid by the Fund.

The Fund did not rely on any recommendation or approval of its Independent Review Committee to proceed with any transaction involving related parties because it did not conduct any related party transactions, except for certain inter-fund trades and the management and administrative fees as described above, as approved by the Independent Review Committee by standing instructions, and subject to regulatory requirements.

Management Fees: As Manager, BG is paid a management fee from each class of the Fund based on the average daily net asset value of the particular class. The fee is payable monthly, in arrears, and is calculated at the annualized rate specified for each class of the Fund as set out in the table below. Management fees for Class I units are negotiated and paid directly by the investor, not by the Fund, and, therefore, are not listed.

Administration Fee: The Manager receives a fixed administration fee to pay certain operating expenses of the Fund. These expenses include audit and legal fees; custodian and transfer agent fees; costs attributable to the issue, redemption and change of units, including the cost of the security holder record-keeping system; expenses incurred in respect of preparing and distributing all regulatory reports; fund accounting and valuation costs; independent review committee fees and filing fees, including those incurred by us. The administration fee may vary by class of units and by Fund.

BG, as trustee of the Fund, earns a fee which is paid by the Manager from the administration fee paid by the Fund.

- (4) This information is provided as at period end of the period shown.
- (5) Management expense ratio is based on total expenses (excluding commissions and other portfolio transaction costs) for the stated period and is expressed as an annualized percentage of daily average net asset value during the period.
- (6) The Manager may have waived or absorbed some of the fund expenses. If this had occurred, the management fee ratio before any such waiver or absorption is listed. The Manager may terminate the waiver or absorption at any time, at its discretion. It is not known when such waivers or absorptions will be terminated.
- (7) The Fund's portfolio turnover rate indicates how actively the Fund's portfolio advisor manages its portfolio investments. A portfolio turnover rate of 100% is equivalent to the Fund buying and selling all of the securities in its portfolio once in the course of the fiscal year. The higher a Fund's portfolio turnover rate in a year, the greater the trading costs payable by the Fund in the year, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a higher turnover rate and the performance of a Fund. Portfolio turnover rate equals the lesser of the costs of purchases and proceeds of sales of portfolio securities for the period divided by the average value of the portfolio securities of the Fund calculated on a monthly basis, excluding short-term securities.
- (8) The trading expense ratio represents total commissions and other portfolio transaction costs disclosed in the Statements of Comprehensive Income expressed as an annualized percentage of daily average net asset value of the Fund during the period.

Past Performance

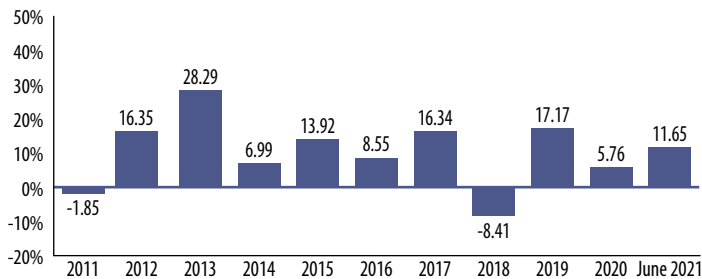

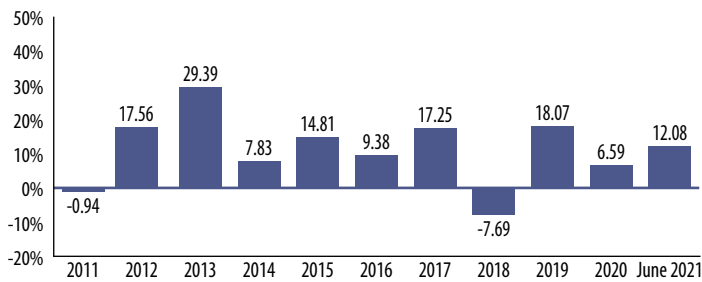
Year-by-Year Returns

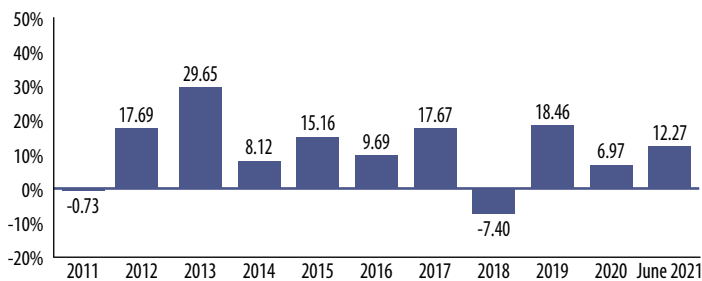

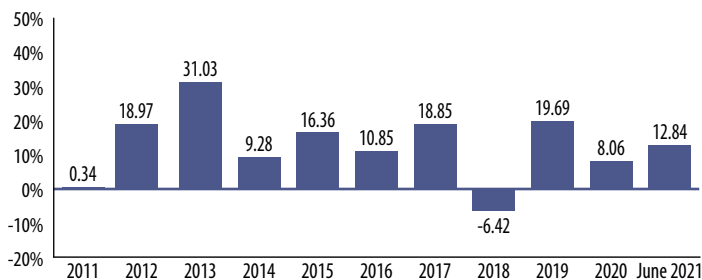

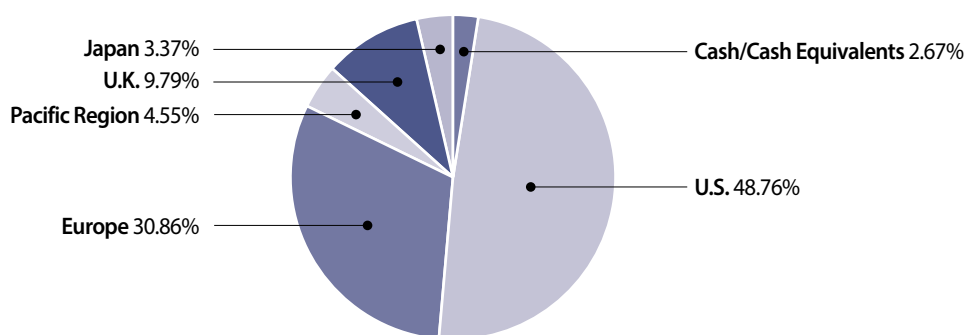
